#### 4. Definitions

For purposes of this indemnity and Consent Form the following words will bear the following meanings and similar words will bear corresponding meanings:

- 4.1 "Criminal Record Check" means the criminal record check that Afiswitch will conduct, at the Applicant's request, in respect of the Applicant.
- 4.2 "Data" means the Applicant's personal information is provided to Afiswitch by the Applicant for purposes of conducting the Criminal Record Check, such data includes, without limitation, the Applicant's name, surname, address, mobile number, identity number and fingerprints.
- 4.3 "Data Findings" means the Applicant's personal information that is obtained by the Afiswitch and its Third Party Verification Suppliers during the course of performing the Criminal Record Check, such data findings includes, without limitation, a detailed summary of the Applicant's criminal record (including, without limitation, information regarding the Applicant's criminal history, previous convictions, cases awaiting trial and /or any other relevant information such as is ordinarily furnished by the Criminal Record Centre of the South African Police Service.
- 4.4 "Personnel" means any officer, director, employee, agent, consultant, contractor or other representative of a party; and
- 4.5 "Third Party Verification Suppliers" means the third parties' acting on behalf of Afiswitch, including, without limitation, criminal record bureaus, governmental bodies (including the South African Police Service) and fraud prevention organizations.

#### 5. Consent

- 5.1 I (the applicant) hereby authorize Afiswitch and its Third Party Verification Suppliers, to access, use, store and transfer my Data for purposes of conducting the Criminal Record Check. In this regard I acknowledge and agree that my Data may be shared by Afiswitch with its Third Party Verification Suppliers for purposes of performing the Criminal Record Check.
- 5.2 In addition to clause 5.1 above, I hereby authorize Afiswitch and its Third Party Verification Suppliers to retain, store, use and transfer the Data and Data Findings for any other legitimate purpose, including the purposes of verifying my identity which will include comparing and verifying the Data and Data Findings against any national data registers.
- 5.3 I hereby agree that the Data Findings (including, without limitation, any adverse findings, which will include my criminal record and any cases against me that are pending/ awaiting trial) may be shared by the Third Party Verification Suppliers with Afiswitch. **I hereby indemnify and hold Afiswitch and its Third Party Verification Suppliers and their respective Personnel harmless in full for, from and against any and all loss, damage, injury, liability, costs and expenses suffered or incurred by me whether directly or indirectly out of or in connection with the Criminal Record Check and the use, storage and transfer of the Data and Data Findings and/or any errors or omissions contained therein, irrespective of whether such errors or omissions occur as a result of Afiswitch, its Third Party Verification Suppliers and/or their respective Personnel's negligent acts or omissions. In particular I acknowledge and agree that Afiswitch and its Third Party Verification Suppliers and their respective Personnel will not be liable, under any circumstances whatsoever, for any loss, damage, injury, liability, costs and expenses suffered or incurred by me whether directly or indirectly out of or in connection with my and/or any third party's reliance on the Data Findings, including without limitation, any decisions that I and/or any third party may make based on such Data Findings.**
- 5.4 I further agree that the Data and Data Findings may be transferred cross-border to other countries, which do not necessary have data protection laws similar to the Republic of South Africa, for verification or storage purposes. In any cross-border transfer of the Data or Data Findings the recipient will be notified of the requirement to keep the Data and Data Findings confidential.
- 5.5 I warrant that the Data provided to Afiswitch is accurate and current and that I have not knowingly withheld any facts or circumstances. I agree that I will correct and update the Data when necessary. **I hereby indemnify and hold Afiswitch and its Third Party Verification Suppliers and their respective Personnel harmless in full for, from and against any and all loss, damage, injury, liability, costs and expenses suffered or incurred by Afiswitch and/or its Third Party Verification Suppliers and/ or their respective Personnel whether directly or indirectly out of or in connection with any incorrect or false information or Data submitted by myself.**
- 5.6 I understand that Afiswitch and its Third Party Verification Suppliers will use reasonable efforts to maintain the confidentiality of the Data and Data Findings and that the Data and Data Findings will be stored in a secure manner and accessed and transferred for the purposes I have authorized.
- 5.7 By signing this Indemnity and Consent Form, I warrant that I am an adult of sound mind and declare that I have read through this Indemnity and Consent Form and I know and understand its terms and the consequences thereof and fully agree to bind myself to these provisions.
